The Carlsbad Oceanside Art League ("COAL" or the "League") is a non-profit organization the purpose of which is to promote the education and cultural appreciation of fine arts in the community. This purpose shall be supported, as funding allows, by demonstrations, student programs/scholarships, outdoor displays, exhibitions, commercial displays, miscellaneous cultural tours, and a main gallery. (Paraphrased from the League Bylaws).

THINGS YOU SHOULD CONSIDER BEFORE JOINING COAL

League Activities and Services provided: 1) Month-long show in our gallery every month, 2) Live monthly demonstrations at the Calavera Hills Community Center, 2997 Glasgow Dr, Carlsbad, CA 92010. 3) Monthly informational Eblasts and a newsletter, *The Brushmark*. 4) An annual Membership Directory. 5) Several annual awards show for members and non-member artists. 6) Children and students' art from the local community. 7) A sponsorship of a weekly outdoor artist's sales show in front of the Carlsbad Inn (for qualifying members). 8) Gallery storefront sales and demonstrations opportunities.

Yes, the League does many things for its members and for the community but it is, after all, a *volunteer cooperative organization*. Thus, members are expected to assume certain individual responsibilities, to wit:

- Pay dues annually and on time (except for Life Members)
- Advise the Director of Membership of a significant change to any of the pertinent information solicited on the front of this form.
- Become familiar with the standard operating procedures of the gallery by reading the available material and complying with these procedures while serving as gallery attendant.
- Faithfully fulfill gallery hosting obligations, or provide a member substitute host at your own expense (typically \$35 per three hours).
- Volunteer for any open positions available listed above and/or assist at a one- time event as required from time to time. The Jobs Signup list is available online at https://docs.google.com/spreadsheets/d/1bBsSl6RBJveyo2EOzVy20eASVkpMuH74OXdBjIX_aYA/edit?usp=sharing
- Support the League by showing artwork at least three (3) times a year in the gallery.

The most important is to fulfill your hosting obligations, and when you bring artwork to the gallery for display each month, you obligate yourself to be the gallery attendant for the month -- to greet and assist customers, make sales, etc., -- normally for just one 3-hour day session if you bring in 4 pieces or fewer. Choose your own hosting period from those available when you bring in your work (generally, the first Monday of each month). But, once chosen, it is your responsibility to either host at the gallery as scheduled, find someone to swap with, or provide a substitute (who must be a League member) at your own expense of \$35 per hour.

Beyond the above criteria, we invite you to find out about how we operate -- how our activities are run and what our policies and procedures are. The latter of these are covered in some detail in a ***Procedures Manual*** at the Gallery, and are available for your inspection. Our procedures manual goes into detail on what is acceptable. Please familiarize yourself with it in advance. And of course, the League member on duty can answer your questions as well. IRS rules require COAL to file a 1099 reporting more than \$600 in sales for any one artist.
