

ARTWORK RULES GUIDELINES: SHRINK WRAPS & CARDS

SHRINK-WRAPS	CARDS & PACKAGES
SCHEDULE: Is in 3-month periods JAN-MAR, APR-JUN, JULY- SEPT, OCTDEC	SCHEDULE: Is in 3-month periods JAN-MAR, APR-JUN, JULYSEPT, OCT-DEC
\$5.00 increments <u>6 shrink-wrap maximum allowed</u> during the 3-month periods. All art must be removed at the end of each 3-month period and must be picked up, regardless of show entries. No larger than 16x20	\$5.00 increments 12 single marked cards or 6 card packages, or a combination thereof, not to exceed a total of 12 entries. are allowed during the 3-month periods. All cards will be removed at the end of each period, regardless of show entries. Cards no larger than 5x7. Small one fall out.
Provided you have paid at least one fee for a Monthly Show Entry, in any 3-month period, you are allowed up to a maximum of 6 shrink- wraps in a 3-month period . The Director of the Gallery reserves the right to further restrict the number of entries when space limitations are a factor.	Provided you have paid at least one fee for a Monthly Show Entry, in any 3-month period, you are allowed up to a maximum of 12 cards or 6 packages in a 3-month period . The Director of the Gallery reserves the right to further restrict the number of entries when space limitations are a factor.
Shrink-wraps must be properly matted, or with an appropriate mat or backing. No corrugated board, or foam core is allowed. Art that is not shrink-wrapped must be wrapped in clear plastic or, preferably, packaged in poly art bags. They	Artist is <u>allowed three card slots per 3-month</u> period. (we will be reassessing space requirements at month's end, and you will be notified via eblast.)
must be sealed. <u>Masking tape is not allowed</u> . Use your OWN LABEL. Each shrink wrap MUST BE LABELED original or print. When entering shrink-wraps, each entry must be affixed with artist name, title (if used), price on the back of the work. We no longer record or log items into the gallery. Giclee's, photographs and other print reproductions are placed in the Reproduction or, Print bins.	Cards must be wrapped in clear plastic or, preferably, packaged in poly art bags. They must be sealed. <u>Masking tape is not allowed.</u> Use your OWN LABEL: Each card MUST BE LABELED: They must be affixed with artist name, title (if used), price on the back of the work. We no longer record or log items into the gallery.
