“Spa Season” in Karlovy Vary.

Current Members (2020) are eligible to submit a 4-

piece group of their art-to be juried by Jack Ragland. The selected 4-piece groups(4 fine artists and one photographer) will be packaged and sent to Karlovy to be framed and displayed during this Grand Opening period. Your art may be displayed framed or unframed for jurying, but will be **sent unframed**. They are NOT for sale.

- The unframed art(two-dimensional) needs to be 16" x 20" or less (unframed) in size: metal is acceptable. It will be carefully packaged and shipped. (by March 15th) I will then be packaged and returned to the Gallery for pickup.
 - To participate in the selection we will need a check for \$40.00 made out to Carlsbad-Oceanside Art League to cover expenses.
 - Your 4-piece group, along with your check, needs to be present at the Gallery, ready to be juried in March 6th, at 10:00AM.
 - If selected, we will also need to have your bio available to be sent to be available to viewers.

His works are in private, corporate, and public collections in the USA and Europe, including the following: the Los Angeles County Museum; the Phoenix Museum; the Albertina Museum; Vienna Austria; the Kunstmuseum, Basel, Switzerland; the Bibliotheque National, Paris, France, and many more.

Entry Fees: \$18 each

Limit of 3 entries per member

MEDIA CATEGORIES: Oil/Acrylics, Water Media, Pastels, Drawing/Printmaking, Mixed Media/Collage, Photography, Digital/Computer Art, and Sculpture.

SPECIFICATIONS: All work must be suitable for general viewing. All hanging submissions must be dry, framed with gallery quality frames with D-rings and have sturdy wire attached with taped ends, ready to hang. Center of wire on wall hung entries must be no less than 3" from top of frame. NO sawtooth hangers or screw eyes will be accepted. Maximum weight for hanging submissions is 15 lbs (10 lbs if over 45" wide). Diptychs and triptychs are considered as one entry. Work on paper must be under glass or Plexiglas (Plexiglas only if work is 24" x 30" or larger) – (pastels exempt from Plexi). Sculpture (non-hanging) is limited to 50 lbs., must be attached to its base, and 60 inches or less on longest length. Limit of 3 entries per artist sized as follows for wall-hung pieces: The sum of the

diagonal (corner to corner) measurements of ALL entries (including frames) not to exceed 110 inches and no single entry may have a diagonal measurement over 60 inches. All entries must be For Sale (no NFS).

ELIGIBLE ART WORK: All work must be original, done in the past 2 years, and may not have won a cash award in a previous COAL show. No work from workshops or classes and no work using copyrighted source material unless you own the copyright. No reproductions of work are allowed.

JUDGING RULES: Categories with fewer than 5 entries will be judged but are not required to receive a prize. An artist may not win multiple cash awards in a single category. For purposes of this rule, Best of Show is considered a separate category.

NOTE: You may enter a maximum of 3 pieces in the Members Award Show. If our walls can't handle all of the art, **AFTER JUDGING, NON-AWARD** pieces will randomly be removed and shown at no charge in the April 2020 show.

LIABILITY: The League, its Officers, Directors, agents and representatives assume **NO** responsibility for damages to, theft or loss of entries in the show. All entries are subject to these conditions. Insurance is the responsibility of the

member. Your signature on the entry form acknowledges your understanding of COAL's liability clause.

*NOTE: Membership dues for 2020 MUST BE PAID prior to or at Take-in, to enter this show.
