<u>Categories:</u> Oil, Acrylic, Watermedia, Mixed Media/Collage, Photography, Digital Art, Other Media: Includes, Pastels, Drawing/Printmaking, Sculpture, 3D/Wall- Hanging Sculpture, and Textiles. Giclee's are accepted but not judged. No Al or Dyptichs, (unless each pieces is paid for separately)

<u>Up to 4 pieces are accepted.</u> 2D/3D wall <u>hanging art</u>: No larger than a 16x20 (including the frame), not to exceed 27 inches, (measured on the diagonal). 3D Free standing sculpture: 36" inches up to 60" inches and secured to a base. 3D pedestal sculptures: may not exceed 36 inches and the base can be no larger than 14 inches.

Wiring requirements: D-Rings and wire are only accepted. All wires must not extend (when stretched at its apex) more than 3" below the top of the frame. Eyehooks may be used if inserted on the inside of the frame so they are not exposed. Smaller artworks might present a tipping issue with these measurements, if you have an issue, with wire than use 1/3 from the top of the artwork

<u>Eligible Artwork:</u> All work must be original, and may not have won a cash award in any previous COAL show. No Al, diptychs or triptychs are accepted. No copyrighted source material unless you own the copyright.

Maximum Weight and Measurements:

2D Artwork and 3D wall hanging must not be over 5lbs. **3D pedestal sculptures** must not be over 40lbs, the base can be no larger than 14 inches. **3D Floor Sculptures** must be secured to a base and cannot be not over 50lbs.

Entry Fees are non-refundable

Members: All 2D & 3D Wall Hanging Sculptures fees are \$11 per entry with (2) Hosting's are required for NOV/DEC. All 3D free standing art entry fees are \$15 up to 36" inches and \$20 up to 60" inches,

 $\textbf{\textit{Non-Members}}, \text{ all 2D \& 3D Wall Hanging Sculptures fees are $13 per entry}. \text{ Not to exceed 27}" on \text{ the diagonal.}$

All 3D free standing art entry fee is \$ 20 up to 36" inches and \$25 up to 60" inches.

Non-members: May Join the COAL BEFORE entering the show to take advantage of the lower fees.

Pricing Art: Minimum sale price is \$25.00 and art must be priced to include CA Sales tax @ 7.750%, Gallery takes a 20% commission, plus a 3% commission for credit card sales. Artwork sold <u>may be replaced</u>, for an additional \$10 fee, payable at the gallery, **and must be the same size as art that was sold**, provide your identification, name, title, and price. **No, "not for sale"** entries are accepted.

You will be signing a Hold Harmless Waiver which will be included in your email submission acknowledgement

<u>Sales Important</u>. All art sales over \$600, the artist is to provide a W-9 prior to mailing funds. All sold artwork will be funded the following month, by the 10th day via a bank draft.
