ENTRY FEES

Members: \$35 for up to 2 each, and \$15 for each additional entry.

Submit: Up to a maximum of 3 pieces, only. (1) may be large up to 60 inches, measured on the diagonal. (frame included) All entries or any combination thereof must not exceed 100" in a total diagonal measurement. Oversized entries not meeting these requirements will not be accepted at take-in.

Review: Please comply with **All our Art Preparation Guidelines** provided online for Monthly Shows on the Members Info page of our website. Oversized entries not meeting these requirements will not be accepted at take-in.

MEDIA CATEGORIES: Oil; Acrylics; Watermedia; Other Media includes: Pastels/ Drawing/Printmaking/Alcohol ink; Mixed Media/Collage; Photography; Digital Art; Sculpture\Wall hanging Sculpture; and Textiles. Giclée's are accepted but not judged. AI is not accepted. **Please make certain you have your art is listed in the correct category** for labeling and jurying purposes.

EXCEPTIONS TO ELIGIBLE ARTWORK: All artwork must be for sale. Any works that have won a previous cash award in a previous NCAG/COAL open show are not eligible for awards All diptych/triptychs are eligible if they are hinged/secured together, otherwise they count as individual pieces, and paid for separately at the price of 2ea or 3 ea.. Plexiglass must be on artwork that is 24x30 and larger. No glass is allowed to hang in the gallery on larger pieces.

ART DROP OFF: **AUG 2.** In person or via substitute person only. The Gallery is open 9:30am – 1pm for take-in on August 3. **No early drop offs**, we have no storage space,

please plan ahead for delivery, or contact another artists to assist you with your delivery.

Hold Harmless/Liability Waiver: All artists are required to sign our agreement which is included in your application online. Please review it carefully before submitting your application.

SALES: The gallery takes 20% + 3% (if a credit card) is used for purchase and includes sales tax. **Art sold may be replaced for a fee of \$10 to the gallery on the date of the replacement and must be the same size as what you are replacing. No nails are to be repositioned to accommodate an oversized piece. You must provide a typed label to accompany the replacement art pice. No handwritten labels are allowed on the walls. Plexiglass is required on pieces over 18x24 in size , (frame included)**
